Specifically, you may not share Magellan Confidential Information with Centene or Centene Confidential Information with Magellan despite the fact that the companies are now affiliated.

### FREQUENTLY ASKED QUESTIONS

# 1. What are examples of information and data that are proprietary, commercially sensitve or confidential customer information?

Examples include, but are not limited to, claims and enrollement data (including reports and performance metrics); financial, operational or technical information (including contract terms, pricing and fees, financial records, marketing plans, research data and outcomes); and present and proposed products, trade secrets, know how, systems processes, descriptions of software tools, functions and features, computer source codes, methods for information systems integration. Please contact the Strategic Sourcing and Procurement Department for specific guidance.

## 2. Can we provide products and services to Magellan and Centene under the same contract?

Contracting questions must be addressed case by case with the Strategic Sourcing and Procurement Department. In any event, the prohibitions on sharing Confidential Information will apply to services provided to both Magellan and Centene under a single contract.

## 3. What should we do if we disclose or share Magellan customer data or other information to unauthorized Centene personnel in error?

Please immediately report this incident to the Magellan Compliance Hotline at 1-800-915-2108. Each call to the Compliance Hotline will be investigated and treated confidentially and callers have the option to remain anonymous. Vendors may also report suspected or actual violations via email to the follow address: <u>compliance@magellanhealth.com</u> or via <u>www.mycompliancereport.com</u>, entering "MGH" as the client code. Magellan Health prohibits employee intimidation and retaliation against anyone reporting suspected compliance violations.
